Thank you for your interest in performing at the Tacoma Farmers Market! For programmatic reasons we ask that you fill out this application, which allows us to schedule you on the most appropriate days. Note that you must be booked by March 31st to be mentioned in any marketing media we send out.

1. Mark the days you are interested in appearing at the market. The Performance Artist Coordinator will contact you to solidify your performance dates and times.
2. Your signature on this form confirms your ability to perform on those selected dates and we appreciate at least a **one-week** notice if you cannot make the performance. We understand that things come up but this gives us an opportunity to fill that time slot to another artist.
3. The requesting organization or artist, you, must provide your own equipment unless prior arrangements have been made with the Market Manager to use market equipment (e.g. we do have a sound system, a portable stage, etc...). No microphones/electronically-enhanced performances are permitted without prior approval from the Market Manager.
4. Performing artists must honor all Market Rules where applicable. You will find a copy of these on the vendors page of our website.
